



FISCAL YEAR 2017 IS OFF TO A BUSY START

During the first quarter of fiscal year 2017 (October 1 to December 31, 2016), the Department of Commerce (Commerce) issued 11 new AD/CVD Orders and initiated 16 new AD/CVD investigations.

The new orders covered hot-rolled carbon steel flat products from Australia, Brazil, Japan, Korea, Turkey, United Kingdom and Netherlands, as well as welded stainless pressure pipe from India.

A few examples of the AD/CVD investigations initiated in the first quarter of fiscal year 2017 include: hardwood plywood from China, stainless steel wire rod from India, softwood lumber from Canada, certain welded stainless steel pipe from Korea and Taiwan, and cut-to-length carbon-quality steel plate from India, Indonesia and Korea.

FILING AD/CVD ENTRIES WITH NEW 2017 HARMONIZED TARIFF SCHEDULE (HTS) NUMBERS

ACE will now allow the use of an AD/CVD case number on an entry/entry summary line even when the corresponding HTS number is not yet listed in the ACE case reference file for that AD/CVD case. This was addressed in Cargo Systems Messaging Service (CSMS) #16-000466 dated June 7, 2016.

If brokers receive an error messages back from their own software, they should contact the software vendor to address any restrictions that may be preventing the proper filing of an AD/CVD entry/entry summary. Also research the ACE CATAIR Error Dictionary for the meaning of ACE error code(s) and determine whether they are fatal or informational in nature. The ACE CATAIR Error Dictionary:
