

# Implementation of Additional Required Data Elements for Enforcing Sanctions on Russian Diamonds and Seafood

Last updated: March 17, 2025



U.S. Customs and Border Protection (CBP) plans to begin collecting additional required data elements in the Automated Commercial Environment (ACE) for merchandise subject to sanctions on Russian diamonds and seafood. This automation supports [Executive Order 14114](#). CBP [proposed additional data element requirements in the Federal Register](#) on October 22, 2024. Any future updates to this notice will be announced via the Cargo Systems Messaging Service (CSMS). This deployment includes Electronic Data Interchange impacts.

## What will change for trade users?

- **For applicable seafood imports filed in ACE:**
  - For all methods of harvest, this update will require filers to provide:
    - *Country of Harvest*
    - *Method of Harvest*
  - For the vessel method of harvest, this update will require filers to provide:
    - *Vessel Name*
    - *Vessel Flag*
    - *Vessel International Maritime Organization (IMO) number*
- **For applicable diamond imports filed in ACE:**
  - This update will require filers to provide the *Country of Mining*.
  - For imports of jewelry that exclude diamonds, but which fall under an applicable Harmonized Tariff Schedule of the United States (HTSUS) subheading, filers will have the option to disclaim the additional data requirement.

## Other changes related to Executive Order 14114

- In addition to the data elements outlined above, CBP also currently requires filers to provide self-certification statements for applicable seafood and diamond imports to verify that the imports do not contain Russian inputs. These self-certification statements must be provided via the Document Image System.
- On November 4, 2024, CBP updated the [ACE Document Image System \(DIS\) implementation guide](#) to add a new document label code for self-certification statement submissions.
  - New Document Label: IMPORTER\_SELF\_CERTIFICATION (DocCode: *CBP167*)

Currently, filers submit the self-certification statement via the *Other* document label code (DocCode: *CBP03*).

- As announced in [CSMS #63361497](#), beginning on January 27, 2025, filers must use the new document (*CBP167*) to submit a self-certification statement to CBP via DIS.
