APPENDIX U – HTS/Schedule B Classifications Requiring Used Vehicle Reporting (Input EV1 Record)

HTS/Schedule B classifications deemed ‘used self-propelled vehicles’

Report an Input EV1 Record in a commodity filing of a classification deemed a ‘used self-propelled vehicle’. The Input EV1 Record includes the Vehicle Identification Number (VIN) or, if the vehicle does not have a VIN, the Product Identification Number (PIN). Those numbers highlighted in bold require the EV1 record, the other numbers will allow an EV1 record to be reported. Only the HTS/Schedule B classification on this list allow an EV1 record to be filed. An EV1 record is not allowed for other classifications.
