

Continued Dumping and Subsidy Offset Act of 2000 (CDSOA) FY 2016 Preliminary Amounts Available as of April 30, 2016

This report supplements CBP's Notice of Intent to Distribute CDSOA offsets for FY 2016. In particular, this report provides the preliminary dollar amounts subject to distribution that are contained in the Special Account for each order or finding, as of April 30, 2016. The final amounts available for disbursement may be higher or lower than the preliminary amounts shown here due to liquidations, reliquidations, protests, and other events affecting entries that may take place between now and the end of the fiscal year. In addition, these preliminary amounts do not reflect amounts subject to distribution under Section 605 of the Trade Facilitation and Trade Enforcement Act of 2015, which will be included in the FY 2016 distribution, because those amounts were not available as of April 30, 2016. Any negative amounts in this report indicate amounts to be returned as a result of reliquidations or other administrative action on cases where CDSOA disbursements were made in a prior fiscal year.
