Stainless Steel Flanges from the People's Republic of China: Countervailing Duty Order

On April 12, the Department of Commerce published its affirmative final determinations that countervailable subsidies are being provided to producers and exporters of stainless steel flanges from China. On May 29, the International Trade Commission notified Commerce of its affirmative determination that an industry in the United States is materially injured, by reason of subsidized imports of subject merchandise from China. As both the Department and the Commission have reached affirmative determinations, Commerce will direct CBP to assess countervailing duties for all relevant entries of stainless steel flanges from China. Clarification: Correct Use of the Special Value Fields, Multiple Entry Line and Set

CBP is issuing updated guidance on the correct use of the Antidumping and Countervailing Duty special value field. These special value fields on the entry summary record may now be used when a value or quantity is different from the standard CBP appraised value that must be used to calculate duties for goods on a line that are subject to an antidumping or countervailing duty proceeding. CBP has provided detailed guidance and graphical representations of how the Antidumping and Countervailing Duty Value of Goods Amount should be reported in the Automated Commercial Environment system, depending on the nature of the imported merchandise. Home Furnishings Resource Group Inc. Agrees to Pay \$500,000 to Settle False Claims Act Allegations Relating to Evaded Customs Duties

The Department of Justice announced that Home Furnishings Resource Group Inc. has agreed to pay \$500,000 to resolve allegations that it violated the False Claims Act by making false statements on customs declarations to avoid paying antidumping duties on wooden bedroom furniture imported from the China.
