In-bond Common Errors

The In-bond Error Message Dictionary identifies error messages encountered in transmitting ACE ABI CATAIR records in QP and WP format and explains the reason for the error message.

001 OP30 RECORD MISSING

Record Identifier QP30 - QP10 Action Code is 'A' and QP30 record is missing.

or

Record Identifier QP30 – QP10 Action Code is 'B' and QP30 record is missing.

002 OP10 COUNT EXCEEDED

Record Identifier QP10 - Used more than once per B-Y Block for QP10 Action Codes 'A' and 'B'.

or

Record Identifier QP10 - Used more than 999 times per B-Y Block for QP10 Action Code 'D'.

003 OP40 RECORD MISSING

Record Identifier QP40 - Data was not transmitted when full bill data is transmitted within the QP message.

004 NO SHIPPER DATA FOUND

Record Identifier QP50 - Data was not transmitted when full bill data is transmitted within the QP message.

005 NO CONSIGNEE DATA FOUND

Record Identifier QP55 Consignee Name/Address Record - Not transmitted when full bill data is transmitted within the QP message.

006 OP30 LOOP COUNT EXCEEDED

Record Identifier QP30 - Used more than 9999 times per QP10.

007 NO CARGO DESC DATA FOUND

Record Identifier QP71 - Data was not transmitted when full bill data is transmitted within the QP message.

008 NO INBOND DATA FOUND

Record Identifier QP10 - In-bond Number data element is missing.

or

Record Identifier QP10 - In-bond Number not on file for QP30 Bill Delete.

or

Record Identifier QP10 - In-bond Number not on file for QP10 In-Bond Delete.

009 INVALID CARRIER CODE

Record Identifier QP10/QP20 - Carrier Code data element contains a code not in carrier record file.

or

Record Identifier QP10/QP20 - Carrier Code is missing.

010 INVALID TRANSPORTATION MODE

Record Identifier QP20 - Mode of Transportation Code data element contains values not specified in the Implementation Guide.

or

For WP to report FDA Prior Notice, this error is returned if the affirmation of compliance RNO (Rail Car Number) is sent with an MOT other than RAIL (20 or 21).

011 INVALID VESSEL COUNTRY CODE

Record Identifier QP20 - Importing Vessel Country Code data element contains invalid country code.

012 INVALID VOYAGE

Record Identifier QP20 - Voyage Number data element is missing.

or

Record Identifier QP20 - Voyage Number data element cannot contain special characters.

013 NO MAN UNIT CODE FOR BL

Record Identifier QP40 - Manifest Unit code is not specified in the Implementation Guide.

or

Record Identifier QP71 - If provided, Manifest Unit Code is not specified in the Implementation Guide.

014 INVALID UNLADING PORT

This message is not currently being used.

015 INVALID EST ARR DATE RANGE

Record Identifier QP20 – When creating non-withdrawal in-bonds the date in the Estimated Date of Arrival data element is before or after 270 days from the processing date of the inbound message.

016 **OP32 COUNT EXCEEDED**

Record Identifier QP32 - Used more than once per QP30.

017 **INVALID BOL**

Record Identifiers QP30 - Bill of Lading Sequence Number data element contains spaces or is not alpha/numeric.

018 **OP33 COUNT EXCEEDED**

Record Identifier QP33 - Used more than 999 times per QP30.

019 **OP40 LOOP COUNT EXCEEDED**

Record Identifier QP40 - Used more than once per QP30.

020 **INVALID WEIGHT**

Record Identifier QP40 - Contains weight information in a format other than numeric, not greater than 0, or is missing.

021 **INVALID WEIGHT UNIT**

Record Identifier QP40 - Weight Unit data element is missing or contains an invalid value per the Implementation Guide.

022 **INVALID VOLUME**

Record Identifier QP40 - Volume Unit data element is provided without Volume data element, or Volume data element is other than numeric or is not greater than zero.

023 **INVALID VOLUME UNIT**

Record Identifier QP40 - Volume data element is provided without Volume Unit data element or Volume Unit data element contains an invalid value per the Implementation Guide.

024 **MISSING NAME**

Record Identifier QP50, QP55, or QP60 - Foreign Shipper, Consignee, or Notify Name/Code data element is missing.

025 **MISSING ADDRESS**

Record Identifier QP50, QP55, or QP60 - Foreign Shipper, Consignee, or Notify Address data element is missing.

026 INVALID SNP PROFILE - XXXXXXXXXX

Record Identifier QP32 - Where XXXXXXXXXX is the Secondary Notify Party (SCAC, FIRMS, or ABI Routing Code) that does not have a valid EDI profile.

027 OP50/OP55/OP60 COUNT EXCEEDED

Record Identifier's QP50 or QP55 - Used more than once per bill of lading (QP30 Record).

or

Record Identifier QP60 - Used more than three times per Bill of Lading (QP30 Record).

028 OP51/OP56/OP61 COUNT EXCEEDED

Record Identifier's QP51, QP56, or QP61 - Used more than once per QP51/QP56/QP61 Record loop.

029 OP52/OP57/OP62 COUNT EXCEEDED

Record Identifier's QP52, QP57, or QP62 - Used more than once per QP52/QP57/QP62 Record loop.

030 INVALID INBOND ENTRY TYPE

Record Identifier QP10 - In-bond Entry Type data element contains anything other than 61, 62, or 63.

or

Record Identifier QP10 - In-bond Entry Type is missing.

031 DUPLICATE CONTAINER FOR THE BILL

Record Identifier QP65 - Cannot repeat the container number or 'NC' within the same bill.

032 INVALID INBOND NUMBER

Record Identifier QP10 - Contains a Conventional In-bond Number where first 8 characters are either not numeric or are all zero's.

or

Record Identifier WP10 - Does not contain an In-bond Number data element when required for specific Action Codes as specified within the Implementation Guide for WP.

033 **INVALID PORT**

Record Identifier QP10 and QP20 - U.S. Port of Destination or Port of Importing Conveyance Arrival data element is missing.

or

Record Identifier QP20 – Port of Importing Conveyance Arrival data element contains a code that does not appear in the Census Schedule D port code list.

or

Record Identifier QP10 - U.S. Port of Destination data element contains a code that does not appear in the Census Schedule D port code list.

or

Record Identifier WP20 - When provided, the Port of Arrival data element contains a code that does not appear in the Census Schedule D port code list.

034 **INVALID FOREIGN PORT**

Record Identifier QP40 - The Foreign Port of Lading is missing.

or

Record Identifier QP40 - The Foreign Port of Lading contains a code that does not appear in the Census Schedule K Foreign Port code list.

or

Record Identifier QP10 - Foreign Port of Destination is missing for In-Bond Entry Type 62 (T&E-Transport & Export or 63 (IE-Immediate Export).

or

Record Identifier QP10 - Foreign Port of Destination contains a code that does not appear in the Census Schedule K Foreign Port code list.

035 **INVALID DOLLAR VALUE**

Record Identifier QP10 - The Value data element is missing when QP10 Action Code is 'A'.

or

Record Identifier QP10 - Value data element contains data that is not numeric or a '0' when QP10 Action Code is 'A'

036 **OP70 COUNT EXCEEDED**

Record Identifier QP70 - Used more than 999 times per QP65.

037 **WP10 LOOP COUNT EXCEEDED**

Record Identifier WP10 - Used more than 9999 times per envelope.

038 BOL ALREADY ON FILE

Record Identifier QP30 - The QP dataset cannot contain Record Identifiers QP40 thru QP76 when the Bill is already on file.

039 WP20 COUNT EXCEEDED

Record Identifier WP20 - Used more than once per WP10.

040 BILL NOT ON FILE

Record Identifier QP30 - Action Code data element with 'D' was transmitted to delete the Bill but the Bill was not on file.

or

Record Identifier QP30 – Action Code data element with 'A' was transmitted to add the Bill to the In-Bond but the Bill was not on file.

041 MISSING CONTAINER NUMBER

Record Identifier QP65 - The Container Number data element is missing.

042 INVALID QUANTITY

Record Identifier QP30 – When provided, In-bond Quantity data element contains data that is not numeric.

or

Record Identifier QP40 - Manifest Quantity data element contains a quantity that is not numeric, equal to '0', or is missing.

or

Record Identifier QP71 - Piece Count data element contains a quantity that is not numeric or is missing.

043 INVALID INBOND CHECK DIGIT

Record Identifier QP10 - In-bond Number data element contains an invalid In-bond Check Digit.

044 INVALID VESSEL NAME

This message is not currently being used.

045 ACTION CODE INVALID OR MISSING

Record Identifier QP10 - Action Code data element is missing.

or

Record Identifier QP10 - Action Code data element contains anything other than a valid code per the Implementation Guide.

or

Record Identifier QP30 - Action Code data element is missing.

or

Record Identifier QP30 - Action Code data element contains anything other than a valid code per the Implementation Guide.

or

Record Identifier WP10 - Action Code data element contains anything other than a valid code per the Implementation Guide.

046 INVALID AMENDMENT CODE

This message is not currently being used.

047 MISSING DESCRIPTION

Record Identifier QP71 - Description data element is missing.

048 INVALID SNP - XXXXXXXXXXX

Record Identifier QP32 - Where XXXXXXXXXXX is the Secondary Notify Party (SCAC, FIRMS, or ABI Routing Code) that contains a code that does not appear on file.

or

Record Identifier QP32 – When QP32 is provided, at least the first Secondary Notify Party in positions 3 to 11 must be provided.

049 SCAC NOT ELIGIBLE FOR NOTIFICATION

This message is not currently being used.

050 INVALID ESTIMATED ARRIVAL DATE

Record Identifier QP20 - Original Scheduled Date of Arrival data element contains an arrival date in format other than MMDDYY for CATAIR.

051 MASTER INBOND NOT INDICATED ON BL

052 BILL COUNT NOT = BILLS READ

This message is not currently being used.

053 ACTUAL ARRIVAL DATE INVALID

061 MANIFEST REJECTED

This message is not currently being used.

or

Record Identifier QP76 - Transmitted without an accompanying Record Identifier QP75 Loop Header.

069 OP76 COUNT EXCEEDED

Record Identifier QP76 - Transmitted in excess of the allowable two Record Identifier QP76 records per Record Identifier QP75.

070 INV HAZMAT CODE OUAL

Record Identifier QP75 - If provided, Hazardous Material Code Qualifier is not found in the Implementation Guide.

071 INVALID FLASHPOINT TEMP

Record Identifier QP75 - If provided, Flashpoint Temperature must be numeric.

072 INV FLASHPOINT TEMP UOM

Record Identifier QP75 - If provided, Flashpoint Temperature UOM is not found in the Implementation Guide.

073 NO HARMONIZED NUMBER FOUND

Record Identifier QP70 - When provided and In-bond Type is T&E '62' or IE '63', the Harmonized Number data element is required.

074 INCORRECT HARMONIZED NUMBER

Record Identifier QP70 - If provided, Harmonized Number Data Element contains data that does not appear in Harmonized Schedule file.

075 COMM VALUE MISSING OR INV

Record Identifier QP70 - When Record Identifier QP10 In-bond Entry Type is T&E '62' or IE '63', the Value data element is missing.

or

Record Identifier QP70 - Value data element is not numeric.

076 COMM WEIGHT MISSING OR INV

Record Identifier QP70 - When Record Identifier QP10 In-bond Type is T&E '62' or IE '63', the Weight data element is missing.

or

Record Identifier QP70 - Weight data element is not numeric.

or

Record Identifier QP70 - Weight data element is missing when Weight Unit is provided.

077 COMM WEIGHT UNIT INVALID

Record Identifier QP70 - When Record Identifier QP10 In-bond Type is T&E '62' or IE '63', the Weight Unit data element contains an invalid value per the Implementation Guides.

or

Record Identifier QP70 - Weight Unit data element is missing when Weight data element is provided.

078 MARKS AND NUMBERS MISSING

Record Identifier QP72 - Marks and Numbers data element is missing.

079 **INVALID FDA BTA IND - MUST BE Y OR N**

Record Identifier QP10 - The FDA Indicator is required for In-bond Entry Type IT '61' or T&E '62'. When required, BTA/FDA Indicator data element in Record Identifier QP10 must be 'Y' for yes or 'N' for no.

080 **FTZ IND MUST BE Y ORBLANK**

Record Identifier QP10 - The FTZ Indicator is not 'Y' or ' ' (space).

081 **MANIFEST TRANSMITTAL**

This message is not currently being used.

082 **MASTER IB-LESS THAN 48 HOURS**

This message is not currently being used.

Record Identifier WP10 - The Action Code is '8' or '9' and the FD05 Master Bill Of Lading and Air Waybill Affirmation of Compliance Code was provided.

325 AWB OR BOL REQUIRED

Record Identifier WP10 - The Action Code is '8' then the FD05 Master Bill Of Lading or Air Waybill Affirmation of Compliance Code must be provided.

329 EST ARRVL DATE LESS THAN TODAYS DATE

Record Identifier FD05 - The FD05 Anticipated Date of Arrival Affirmation of Compliance Code was provided with a Date less than 10 days from the processing date of the WP submission.

330 INVALID FILER

Record Identifier FD05 - The Entry Filer Code Affirmation of Compliance Code reference is not on file.

or

343 INVALID BILL TYPE

Record Identifier Z - Port of ABI Receiver and Receiver Filer Code data elements do not match A record data elements.

351 INBOND QTY GREATER THAN BILLOTY

Record Identifier QP30 - The In-bond Quantity cannot be greater than Bill Quantity on file in AMS.

352 INBOND OR BILL DELETE DENIED

Record Identifier QP10 and QP30 - The Action Code of 'D' cannot be used to delete an In-bond on file in AMS by a source other than QP.

353 INVALID CONTAINER NUMBER

Record Identifier WP10 - When Action Code is 3 or 7 the Container Number cannot be 'NC' (Non Containerized).

354 CONVEYANCE ARRIVAL REQUIRED

355 MISSING INBOND QUANTITY

This message is not currently being used.

356 MUST BE EXPORTED AT INBOND LEVEL

Record Identifier WP10 – Export of an In-bond by Bill (Action Code 6) or Container (Action Code 7) is not allowed for Subsequent and less than full bill quantity In-bonds. These In-bonds must be exported at the In-bond level (Action Code 5)

357 MUST BE ARRIVED AT INBOND LEVEL

Record Identifier QP10 - When In-bond Type is '63' and the In-bond Destination is a Port on the U.S. southern border with Mexico, the Mexican Pedimento is required with the QP33 Reference Identification Qualifier of 'FEN'.

363 INBOND TYPE INVALID FOR INBOND DVRSN

Record Identifier WP10 - When Action Code data element is Z, a request for In-bond Diversion is rejected if the In-bond Number is on file in AMS as In-bond Type 63.

364 DIVERSION DENIED
