This document is not commenting on when and what kind of transaction to use when trade files an entry. It only indicates the flagging that will be enforced when a particular transaction type is filed.

\*These agencies currently do not have HTS flags. However, the agencies still have data requirements that must be met.

\*\*For EPA VNE, Entry type 06, trade must file at either SE/Entry or AE/Entry Summary (if two-step), or at AE/Certified Entry Summary (if one-step).
