



# ACE Secure Data Portal: Overview

The Automated Commercial Environment (ACE) Secure Data Portal (ACE Portal) is a free, web-based entry point designed to connect U.S. Customs and Border Protection (CBP), trade partners and Partner Government Agencies (PGA) involved in importing and exporting goods into and out of the United States. ACE Portal users benefit from real-time access to trade data through these capabilities:

- Importer Account Management
- Exporter Account Management
- Protest Filer Account Management
- ACE Reports

## With an ACE Portal Account, users can:

- Review and manage account information
- Access transaction and financial data in ACE Reports
- Customize Periodic Monthly Statement (PMS) payment schedules
- Create blanket declarations for entry summary transactions
- Respond electronically to CBP and PGA requests for information

## ACE Reports

Improve compliance with trade laws by running targeted reports to conduct in-house audits, identify systemic errors and provide insight to those transactions under review by CBP:

- Identify unauthorized filers
- Monitor entry, entry summary, protest and export filing transactions by filer
- Monitor in-bond movements

## Importer Trade Activity (ITRAC) Reports

- Cost-free access to ITRAC data in ACE Reports
- Run reports on demand in real-time
- Importer Self-Assessment (ISA) participants continue to use Customs Trade Partnership Against Terrorism (CTPAT) portal for ITRAC reports
