So there was a mistake made with the photo sent to you. The photograph we received was from someone who volunteers at a shelter. She got that photo mixed up with one she took of another (b) (6), (b) (7)(C) who was just reported as being missing.

His name is (b) (6), (b) (7)(C) from Honduras. And according to someone with him he was left dead, not breathing.

It seems like the group was different, localization info is unknown right now.

I am waiting to get contact info for a family member right now to put them in touch with (b) (6), (b) (7)(C).

Again, the person on the left in the photo is (b) (6), (b) (7)(C), different from the previous case.

About the previous case: (b) (6), (b) (7)(C), his brother heard that his primo recieved a call from him saying that he had been arrested. I wasn't able to get more details because I wasn't able to talk directly to the brother or the primo in that situation. But there seems to be a sliver of hope.



Tucson Sector U.S. Border Patrol has developed the Missing Migrant Initiative (MMI) as a standardized focal point of integration to intake and process all third party missing migrant reports. Additionally, Tucson Sector will assist (b) (7)(E) (b) (7)(E) and foreign consulates in the identification of unidentified dead migrants found within the Tucson Sector Area of Responsibility. This Tucson Sector Border Protection (TCA) methodical collaboration will address national and foreign humanitarian concerns for missing migrants while at the same time leveraging border safety initiatives and providing family reunification.

- MMI is committed in improving the lines of communication with U.S. state, local, and tribal agencies, foreign governments, and non-government organizations. Furthermore, MMI is committed to provide accountability and prompt information dissemination, and collect information that can assist the resolution of missing and unidentified deceased migrants. Information collected will also be considered for future development of border safety campaigns.
- MMI is composed of Border Patrol agents who are experienced in search and rescue operations, CBP database information, and international and border community liaison.
