Department of Transportation OGA-4

The U.S. Department of Transportation (DOT), National Highway Traffic Safety Administration (NHTSA), requires that a Declaration for Importation of Motor Vehicles and Motor Vehicle Equipment Subject to Federal Motor Vehicle Safety, Bumper and Theft Prevention Standards (HS-7) to be filed for merchandise subject to their review.

U.S. Fish and Wildlife Service OGA-5

The U.S. Fish and Wildlife Service requires that the FWS Form 3-177 (Declaration for Importation or Exportation of Fish or Wildlife) be filed for fish, wildlife, or any commodity containing a fish or wildlife product.

Federal Communications Commission OGA-6

The Federal Communications Commissioner (FCC) requires that a FCC-740 (Statement Regarding the Importation of Radio Frequency Devices Capable of Causing Harmful Interference) be filed for merchandise identified as containing radio frequency devices.

Food and Drug Administration OGA-7

The Food and Drug Administration requires that an Importer's Entry Notice, FD 701, form be filed for merchandise subject to their review.

Department of Agriculture..... OGA-9

Allows the filer to electronically query the health inspection certificate as it is transmitted to the U.S. government from the foreign government.

Other Government Agency Rejection Capability..... OGA-9

Provides capability to reject an entry or entry summary for incorrect or incomplete data after passing initial ABI edits.

Other Government Agency Correction Capability OGA-9

Provides filers the capability to electronically correct entry data required by other government agencies.

Multiple Agencies..... OGA-10

Tariff records containing more than one other government agency.
