AMS – Agricultural Marketing Service

The AMS issues export permits for export shipments of fresh grape or fresh apple shipments. The below Harmonized Tariff Schedule (HTS) and Schedule B require these permit numbers to be include on the Electronic Export Information (EEI).

APPENDIX X – HTS/Schedule B Codes for PGAs

ATF – Alcohol Tobacco and Firearms and Explosives

ATF issues export permits (ATF Form 9) for machineguns, silencers, short barreled rifles, short barreled shotguns, destructive devices, and a class of miscellaneous firearms defined by the National Firearms Act as “any other weapons.” ATF does not issue export permits for conventional pistols, revolvers, rifles or shotguns. The Harmonized Tariff Schedule (HTS) and Schedule B codes are not unique for these ATF regulated commodities and therefore no HTS or Schedule B will require the ATF data. The ATF data elements are required for an export shipment when a Federal Firearms License (FFL) and/or permit (ATF Form 9) are required.

APPENDIX X – HTS/Schedule B Codes for PGAs

DEA – Drug Enforcement Administration

The DEA issues export permits (DEA-36) for certain controlled substances and requires an advance notification for the exports of controlled substances (DEA-236) that do not require a DEA-36. The DEA also requires an advance notification for the export of all listed chemicals (DEA-486) unless there's a regulatory exception for the listed chemical. The DEA data elements are required when a DEA permit has been issued or advance notification is required. The DEA has provided a mapping of valid Harmonized Tariff Schedule (HTS) and Schedule B codes (**Master DEA Drug Code-HTS-Schedule B Reference Table.xlsx – can be found using this link: <https://www.cbp.gov/document/guidance/ace-aestir-appendix-x-hts-codes-pgas>**) to its Drug and Chemical codes but as the HTS and Schedule B codes are not unique for only DEA regulated substances they are not required based on the HTS or Schedule B on the shipment.

APPENDIX X – HTS/Schedule B Codes for PGAs

EPA – Environmental Protection Agency

The EPA issue export consent letters on hazardous waste shipments. These consent letters act as permits to allow the export of hazmat shipments of waste. EPA has identified the following codes that will require the additional EPA data elements. There are more commodities or valid Harmonized Tariff Schedule (HTS) and Schedule B codes that can require the EPA data than these identified below, but the HTS or Schedule B is not unique to EPA commodities.

TTB – Alcohol and Tobacco Tax and Trade Bureau

The TTB is collecting information related to the export of alcohol, tobacco, firearms and ammunition where either the liability for tax is relieved or if the export is eligible for a drawback claim on tax paid. The following Harmonized Tariff Schedule (HTS) and Schedule B codes require the inclusion of TTB data on the export shipment commodity filing.
