Executive Summary

The Associated Press reported that DHS Secretary Chad Wolf said Thursday on a visit to Honduras that the countries had finalized the steps on implementing an agreement that would send third country asylum seekers from the United States to Honduras. Secretary Wolf said implementation would begin in the coming weeks.

Bloomberg reported that a federal judge on Thursday cleared the way for a crowdfunded effort to build a section of President Trump's Mexico border wall on private property along the Rio Grande, rejecting concerns that the project may violate an international treaty and endanger a butterfly habitat. The ruling is seen as a victory for Build the Wall.

The Washington Post, ABC News, NBC News and other outlets reported that December marked the seventh straight month of decline in border crossings and month-to-month differences have shrunk significantly since September. In a statement, Commissioner Morgan said: "This seven month decline is a direct result of President Trump's network of policy initiatives and our ability to effectively enforce the law, enhance our border security posture and properly care for those in custody."

The Associated Press reported that the White House said construction of the U.S.-Mexico border wall will move forward after a federal appeals court ruling that frees up construction money. The 2-1 ruling on Wednesday halted a federal judge's ruling in December that had prevented the government from spending \$3.6 billion diverted from 127 military construction projects to pay for 175 miles of border wall. Newsweek and ABC News among other outlets, reported on the court ruling.

For your situational awareness- after further detailed review we just received re: the Blaine POE situation- there were a handful of individuals detailed more than 7 hours. 85% were detained 5 hours or less. One USC couple of Iranian decent was in fact detained for 9 hours. Of note, the couple did have some derogatory information warranting further questioning but it shouldn't have taken so long. It was the result of low staffing. The staffing issues as well as ensuring more effective processing times was

addressed with the POE leadership.

Additionally, we did encounter- during this process at Blaine - one subject with ties to the IRGC.

While it doesn't change our position nor the justification as to what was done and why - the fact it took this long to get accurate reporting from this office is unacceptable and an issue. You have my apologies. I'll be prepared to address tonight. It's been addressed. This is on me.

These incidents are creating consternation and panic within the community, and there is a discussion of internment camps as a part of the planning by the federal government. DHS issues terror bulletin amid Iran tension warning of lone wolf terrorism, cyberattacks (Washington Times)

Acting Homeland Security Secretary Chad Wolf issued a new terrorism threat assessment bulletin on Iran on Saturday, saying there is still no specific credible threat but warning Americans to step up their vigilance.

Mr. Wolf's new bulletin repeated his assurance from a day earlier that there's —no information indicating a threat, but said Iranian officials and some of the terrorist groups it funds have said they want to retaliate after the U.S., on President Trump's orders, killed a top Iranian general with a drone missile strike earlier this week.

The new evaluation laid out a host of potential scenarios for danger, including that Americans here in the U.S. could use the assassination as the catalyst for lone wolf attacks.

—An attack in the homeland may come with little or no warning, the bulletin warns.

It also said Iran could use cyberattacks to retaliate.

—Iran is capable, at a minimum, of carrying out attacks with temporary disruptive effects against critical infrastructure in the United States, Homeland Security said.

Mr. Trump's decision to authorize the strike against Qassem Soleimani, who was head of Iran's Islamic Revolutionary Guard Corps, has ignited a fierce debate in the U.S. over whether his move heads off more violence, or invites it.

Democrats on Capitol Hill complained Mr. Trump bypassed the usual notification system to lawmakers to order the strike. They have said they'll try to pass legislation reining in Mr. Trump and forbidding more escalation.

Homeland Security Issues Terrorism Alert After Soleimani Strike (Free Beacon)

The Department of Homeland Security issued a new terrorism alert Saturday evening following the killing of top Iranian military leader Qassem Soleimani.

In a notification issued under the National Terrorism Advisory System, DHS acting secretary

Chad Wolf said that while there are no "specific, credible threats" against the U.S. homeland, the department is taking proactive measures to ensure Iran and its terror proxies do not conduct a retaliatory attack within the United States.

"At this time there is no specific, credible threat against the homeland," Wolf said. "The Department issued this bulletin to inform, share protective measures, and reassure the American public, state and local governments, and private sector partners that the Department of Homeland Security is actively monitoring and preparing for any specific, credible threat, should one arise."

The killing of Soleimani, an Iranian general and designated terror leader, ignited a firestorm of threats from Iran and prompted fears that Iranian-sponsored groups could mobilize to strike America at home. Hezbollah, one of the regime's most notorious terror proxies, has been found to be operating in Latin America and along the southern U.S. border.

"The Department is operating with an enhanced posture and various operational components are taking protective measures where prudent and necessary. We have been in constant communication with Congress and interagency partners," Wolf said. "The American people should feel assured the entire Department is working for them to keep them safe."

U.S. officials and experts have repeatedly warned in past years that Iran's proxy network is so robust that it could have stationed "sleeper cell" agents who have thus far remained dormant within the American homeland. Already, Iran has launched regional attacks against U.S. military personnel and assets and is threatening further escalations that could spark a wider war with the Islamic Republic.
