- Perform farm and ranch checks, traffic checks, city patrols, and transportation checks

OVERVIEW:

From sky to sea, pilots, mariners and surveillance operators safeguard our country and communities from terrorist attacks and illegal activity.

TYPICAL ASSIGNMENTS:

- Conduct maritime patrols and interdictions of illegal drugs and undocumented non-citizen smuggling in coastal waters
- Conduct airborne surveillance to detect and support the interdiction of unlawful activity

OVERVIEW:

CBP Officers prevent terrorists and weapons from entering the U.S., conduct inspections, and facilitate the flow of legitimate trade and travel.

TYPICAL ASSIGNMENTS:

- Enforce customs, immigration, and agriculture law and regulations
- Facilitate the flow of legitimate trade and travel
- Determine the admissibility of individuals for entry into the U.S.

OFFICE OF PROFESSIONAL RESPONSIBILITY



*INTEGRITY IS THE
MISSION*

OVERVIEW:

The Office of Professional Responsibility (OPR) is the internal investigative arm of CBP which ensures integrity and accountability within the agency.

TYPICAL ASSIGNMENTS:

- Investigate alleged misconduct, criminal activity, and/or corruption by officers, agents, and other CBP personnel
- Respond to and review use of force and critical incidents
- Produce analysis to identify and mitigate threats to CBP

OFFICE OF TRADE



*GLOBAL WORK WITH
COMMUNITY IMPACT*

OVERVIEW:

The Office of Trade facilitates legitimate trade across the U.S. border. It enforces the law to protect the American economy and citizens.

TYPICAL ASSIGNMENTS:

- Develop policy relating to trade seizures, penalties, and liquidated damages
- Engage in international trade assignments to ensure legitimacy and efficiency
- Improve trade processes through research and analysis

OPERATIONAL & PROFESSIONAL SUPPORT

OVERVIEW:

Operational & Professional Support ensures the efficient operation of CBP processes through organization and communication of agency information.

TYPICAL ASSIGNMENTS:

- Facilitate the onboarding and offboarding of employees
- Coordinate training and the distribution of equipment
- Engage in financial services for the agency
- Assist in legal support for the Office of the Chief Counsel
