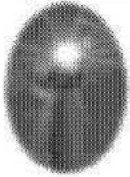

(b) (6), (b) (7)(C) and Chief,

Flagging a comment that B1 made on local radio last week in the chance it comes up at tomorrow's hearing.

Here's the comment: *"And then with respect to the Del Rio event. I think that investigation is going to get wrapped up here relatively quickly. And we're going to find out you know, really, what the truth were was behind that that incident, and I'm confident that almost all those ages will be exonerated. And what we'll find is it was probably, you know, something that was mischaracterized."*

KURV Radio transcript of interview February 23, 2022 at 7:15am

B1:

Thank you Sergio and Tim for having me. And it's always good to come back to Texas. You know I call this my second home. Certainly DC is not my first what I did is about seven eight days ago decided to make a trip down to the most of the Texas sectors. I started out in Big Bend went to Del Rio went to Laredo and then wound up

here in the RGV to really just visit with the troops get a chance to go out and work with them side by side and hear from them some of their concerns that they're dealing with on a daily basis.

KURV:

Take notes from the frontline crew you're listening to. But as we take your message back to DC, I don't think anybody's listening to you.

There are certainly I think is a breakdown in a lot of areas. As you know we were able to bring Secretary Mayorkas down to the border for three days in Yuma, Arizona, that he went down to Laredo and also was able to see I think firsthand in El Paso some of those challenges that those agents have. I will say this that you know, in my 30 plus years I can say that's probably the biggest commitment from a department official to the border. And he took back a laundry list of things that he wanted to work on, in fact, that next Monday, 21 things he outlined that he wanted us to address. And we've started on that list. This isn't a list just for the Border Patrol, but also for ICE and some of the other departments that are out there. So hopefully, we can make some progress on some of those initiatives. But it's not going to be easy.

KURV:

Our national border patrol chief Raul Ortiz they're probably not going to be easy. Probably not going to be too quick. Either way, Washington first, let's and let's talk a little bit more about this because there has been a lot of pushback from the Republican base. Ever since the administration changed the country's approach to immigration and even some pushback from your rank and file. How would you characterize this administration's approach to immigration overall?

B1:

So when you think about, you know, turning that ship 180 degrees, you know, very much a very different approach to your security and immigration situation. It has been quite a challenge for especially some of our younger agents.

KURV:

When you think about somebody has been in this outfit for 2019 construction and that's despite executive order that stops all while building. Where do we stand? We'll part of the wall with those funds be built because that's through the Rio Grande Valley. We're talking all through Starr and Hidalgo Counties.

Yeah, most definitely. So one of the things one of the initiatives on that list of 21 that the Secretary is focused on is closing some of these gates and gaps that we have out there. So there's 68 of them that were approved. And then I've got another tranche of gates and gaps that I want to close. Is there every single one of those gates and gaps an agent is having to sit right there are National Guardsmen are some of the law enforcement officials. And then secondly, with respect to the Appropriations made you think, a little bit over \$2 billion, well, if we're not going to build any new infrastructure with that \$2 billion, what else can we potentially do with that? And this is the technology and I've actually proposed an initiative where we have patrol zones out there with technology linear around detection system, and an enforcement so agents can get into these areas much quicker in patrol laterally, which has always been a challenge for us in my 30 plus years in this outfit

KURV:

Especially in parts of the valley. What's the difference between border wall construction happening and levee wall construction happening right now too?

B1:

Yeah, so some of the levee wall system is a life safety issue is so we're going to go back and remediate those areas. We were started the construction in the levee wall system, and we weren't able to finish. You know, that's an area that's controlled by the International Water and Boundary Commission. And so we recognize the impact that those initiatives may have on these communities. And so we're going to make sure and get those

back to where they were in maybe it's obviously better. So that's the goal with the remediation of the levee system, and that plays out on a lot of locations. It plays out in California. I toured out there, it plays out in Arizona, Southern Arizona, and so we've just got to do a better job of pushing for these projects much quicker. As you know, anytime you do environmental, you work with the corps and sometimes that becomes a bit of a challenge for us.

KURV: For all our teams is the national border patrol chief. Yeah, he went national he was our chief here for many years or number two for many years here in south Texas. And he now leads the gang and border patrol at a very stressful time for Border Patrol. Have the 21 point plan that Secretary Mayorkas developed and handed over to you chief? In general terms would you describe it greater enforcement or it's a reshuffling of policy for a more lenient or softer approach toward the illegal immigration situation you're handling daily?

B1:

Yeah, I'd say really the policy issues and that 21 Point Plan centered around working with the governor of Mexico and regional partners, we think of Honduras, Guatemala, El Salvador, there's other players within the immigration spectrum that certainly need to step up their game.

B1:

A lot of these were very, you know, transactional. Do you think about we need more Border Patrol agents? He's asking for that. I need more processing coordinators. I need to get those 1200 trained that were authorized by Congress. When you think about, what about a contracting vehicle so we can get contractors out in these processing centers. So the Border Patrol just gave get back to their patrol responsibilities. And so we're looking to expense money doing that. So a lot of these things are transactional. And then there are a few policy issues. We're not getting enough prosecutions for agents. I've had over 200 agents assaulted already this year and even though we sit around 70% prosecution rate that should be 90 to 100% prosecution rate. So we're working with the Department of Justice to make sure that that happens. And then you think about the migrant protection protocols. You've got to use that initiative in a way that actually creates a deterrent and forces people to apply for asylum, the correct and legal way. And obviously we've got a court mandate to delivering MPP so when you think about, you know, Southern here in south Texas, you think about El Paso and San Diego. If you're going to do it, you might as well do it. And make an impact.

KURV:

Our national border patrol chief Raul Ortiz in the studio here at Newstalk, 710 KURV, you mentioned the protocol. So percentage wise ballpark figure for how many people are being caught after they enter illegally and being returned under these protocols right now, is that the majority is 30% 75.

What is it because at one time because of these COVID protocols, you never know it might be going away because seems like COVID is going away. In the meantime, we still have and they're supposed to go back and once it needs to go back. Okay, so how many people actually being returned to Mexico the first country that should have given him a site?

B1:

Yeah. So there's two things I think in that question. One, you have the title 42 authority from Health and Human Services, which is the CDC authority to expel people because of COVID and the pandemic and so we're averaging anywhere about 47 48% of those populations, right now are getting repatriated back to Mexico who was much higher, about six, eight months ago, but that number has continued to shrink and over 42 Title 42 Over the last two years. If I had to guess about 50 - 50 30% of them were processing via title eight the way we would normally process a migrant if we had apprehended them, and then turn them over to ice or send them back to their home country. But with the title 42 authority if it's a contiguous country, which is Mexico and Canada, we can send them back as long as they're Spanish speakers and we've been able to do that. And we're trying to expand that right now. Because we know we probably only have that for a small window. We know

for sure that we're going to have it until March 31. We're so we're going to continue to leverage those CDC authorities while we can.

The second thing on the migrant protection protocols. There is a very small percentage that are putting that are placed into that process right now, when under the previous administration, it was much higher

KURV:

And that's the one that the court the High Court said it needs to go back.

B1:

Yes.

KURV:

So what's the delay? Why are they these things?

B1:

You know, one of the parts of the conversation is they have to be awarded access to an attorney. And so that access to an attorney can happen at anytime within that 24 hour period. So that's one of the delay. That's what that the department and this administration made it so that has to happen, and we certainly afford them access to counsel whenever we can.

KURV:

Is Mexico doing its part securing its southern border as a result from various negotiations with the Biden administration.

B1:

Yeah. So you know, I think with our government, Mexico partners, we've seen that they've also got some capacity issues. I think most of the population that we're encountering come through thought by Tula in that southern that, you know, Prudential so we continue to see an awful lot of traffic down there. They tried to have to force that they have to manage their southern border. And then we certainly asked them to help on their northern border with us because we do mirror patrols with them all the time. I think they're stretched awfully awfully thin right now. They're repatriating people back to Colombia, some of these other countries, Haiti, and whatnot. But when you think about the populations that received compared to when I got here in 2013 144 Different countries already, and we're just finished our first quarter of the fiscal year. You think those 144 countries make up Cubans Venezuelans? Nicaragua is Ecuador, as all these countries where we don't have strong diplomatic ties to so how do you put you know, 70-80 people on a plane to send back to Cuba when your relations with them are already strained? And so that becomes a challenge not just for us but ICE.

KURV:

That's a whole different discussion chief Raul Ortiz National Chief border patrol in the studio here KURV

Let's go back to Del Rio from several months ago, and the much-hyped investigation and some secretary Mayorkas all these border patrol on horseback and the initial wrong accusation report that they have been whipping some of these folks who are running from them and those folks, that was wrong, but yet they promised an investigation and some punitive action. What can you tell me from Washington? Has that been closed already? Are we done with that investigation or something? Some of your folks that works are still in trouble being investigated.

B1:

So there's still an investigation that's open. It's being investigated by our Office of Professional Responsibility which is like our internal affairs office, and conjunction with the Department of Justice. I will tell you that almost every agent that was involved in that event is back to work and riding horses, and I had a chance

KURV:

And are we're able to use horses right?

KURV

Anywhere everywhere they need to ?

B1:

Sergio, over the last nine days. I've ridden horses four times with my agents out there in the field to demonstrate to them my support for horse patrol units and what they do each and every day, and they are doing a phenomenal job. And then with respect to the Del Rio event. I think that investigation is going to get wrapped up here relatively quickly. And we're going to find out you know, really, what the truth were was behind that that incident, and I'm confident that almost all those ages will be exonerated. And what we'll find is it was probably, you know, something that was mischaracterized.

KURV:

I could keep talking for at least another hour but of all the questions I got for you. The Texas effort at the border is it making a difference isn't helping in any way some setting up improvised volunteer putting GPS to catch fentanyl? You know, all the resources. The State of Texas is providing some backup behind you Is it helping?

B1:

Yeah, most definitely our partnerships with the State of Texas is phenomenal.

KURV:

How so Chief:

B1:

So I went out yesterday down to Anzalduas Park. There are 37 Texas Game Warden boats out there that are out there patrolling not at any one time, but they're out there, you know, supplementing our Border Patrol units. And on any given day, I may have 50% of my workforce tied down processing and only 50% of them out there in patrol. And so having state troopers, Game Wardens, National Guard, our own DoD efforts out there are a force multiplier. I was working last night till about 10-1030 with the Border Patrol guys, and they were bouncing around all over the sector. And what we saw is a concerted effort, great communication, good collaboration. I wish I could take that and take it up Washington DC because we may have some better success. But I will tell you great partnership there and I think we'd be a much poorer state of affairs without their assistance.

KURV:

As a broadcaster going across the valley and any folks in green uniform out there at the river out there in Lacavina and ranch country. Any words of encouragement? I know in a stressful time morale is low. So what would you say to the frontline Border Patrol gang?

B1: That's a great question. A young supervisor asked me that same question last night. And I told her I said, Hey, listen, you know, one of the things about morale, you know, when we're slow, agents get bored and you know, you start to see morale dip. We're really, really busy right now. So certainly, there is a lack of activity. The agents Got to stay focused on the mission. And we saw that video in Laredo several weeks ago. And that's what we were talking about. Stay focused on the mission. Don't get bogged down in the policy. You know, you can have those conversations on your off time. But at the end of the day, we're out there doing a job that's very, very important. Do everything we can to secure the border. And then with respect, let me fight for the resources that you need. I'm asking for more agents. I'm asking for more technology, better vehicles, better tech, you

know, I need to have a cell phone and every border patrol agents hand out there so they can communicate with each other with the systems that we have already in place. So those are the types of initiatives that I'm working on at the national level. And then certainly trying to make sure our agents are certainly awarded the compensation that they deserve.

DRT Sector has corrected this issue and provided operational guidance to horse patrol. Their duty is to patrol the area and keep order with the migrants' movements as well as look for any migrants that are in need – medical distress, water and food, vulnerable population, etc..

The current situation warrants the ability for migrants to go back and forth in a controlled manner. This is the operational guidance in place.

OPR is looking into the matter to determine if there is any misconduct.

Why is Border Patrol using agents on horseback with whips to control those trying to cross the river?

We are aware of the reporting and are looking into the situation. Any allegation of misconduct will be investigated. We will continue to prioritize processing the migrants here in a safe, orderly and humane way.

Why are you no longer allowing people to move back and forth since for days they were getting food and other supplies like diapers in Mexico and coming back?

We are not preventing their movement, we're processing those under the bridge as quickly, safely, and in as humane a way as possible.

Again, we will review any allegation of misconduct thoroughly. But we have worked hard to ensure the health and safety of everyone involved as we process migrants for return to their countries of origin.

I pasted what I believe to be the concerning part of the story below. We need find out what really happened and if appropriate, report to the JIC/OPR. Also work with OPA with the response.

“Reuters journalists saw mounted officers wearing cowboy hats and vests emblazoned with "POLICE U.S. BORDER PATROL" blocking the path of migrants scrambling up the U.S. embankment carrying plastic bags and cardboard boxes.

After one of the officers in the vests unfurled a cord resembling a lariat like a whip and steered his horse to block the migrants, one tumbled back into the water. He got up and tried again, but the officer swung the cord again near his face.

In another incident, the same officer grabbed the back of the shirt of a migrant trying to run up the bank with bags of food.”

CIUDAD ACUÑA, Mexico, Sept 19 (Reuters) - A U.S. law enforcement officer on horseback wielded what appeared to be a lariat, whipping it close to the face of a man wading in the Rio Grande carrying a plastic bag of food.

It was just one desperate moment in a few hours of such scenes along the Rio Grande on Sunday.

Hundreds of Haitian migrants who have been camping under a bridge in the Texas town of Del Rio were trying to bring food and other supplies from Ciudad Acuña in the Mexican state of Coahuila, while U.S. officials have stepped up security at the border and started flying migrants out of the area, some to Haiti.

Migrants said their squalid encampment under a bridge on the U.S. side of the river was short of supplies. U.S. officials over the last few days had let migrants cross back and forth at a shallow point of the river. On Sunday, however, they told migrants they would not be able to return to the U.S. side if they ventured into Mexico.

"We're trapped," said Joncito Jean, 37, who had spent three days sleeping on a sheet on the ground with his wife and children, ages 3 and 4. He said he regretted the decision to come.

"There are no humane conditions... We have to break out to buy water."

More than 12,000 migrants, identified by officials on both sides as mostly Haitian, have been gathering under the bridge in recent days, awaiting immigration processing. Instead, U.S. officials began removing several thousand people from the camp over the weekend, including some who were later seen arriving in Haiti.

Still, several people who spoke to Reuters, most of whom traveled with their children, said they would take their chances to try to stay in the United States.

Mackenley Pearre, 25, left impoverished Haiti in July with his cousin, wife and 2-year-old daughter due to the worsening violence and inability to find work as an electrician. In July, Haiti's president was assassinated, and in August a major earthquake and powerful storm hit the country.

"You have to do something to not die of hunger," he said, eating a tamale given to him by a local resident on the Mexican side, one of several people who said they felt moved to help.

At a news conference in Del Rio Sunday, U.S. Border Patrol Chief Raul Ortiz said resources were available.

"We are providing food, water, portable toilets, towels, emergency medical technicians are available for first aid," Ortiz said.

"Over the next 6 to 7 days our goal is to process the 12,662 migrants that we have underneath that bridge as quickly as we possibly can," Ortiz said. "What we want to make sure is that we deter the migrants from coming into the region so we can manage the folks that are under the bridge at this point."

At the border, migrants waded deeper to try to evade law enforcement. Mostly men, many barefoot and in boxers, attempted trickier crossings through waist-deep water. Some migrants crossed at another point where water reached their necks.

Reuters journalists saw mounted officers wearing cowboy hats and vests emblazoned with "POLICE U.S. BORDER PATROL" blocking the path of migrants scrambling up the U.S. embankment carrying plastic bags and cardboard boxes.

After one of the officers in the vests unfurled a cord resembling a lariat like a whip and steered his horse to block the migrants, one tumbled back into the water. He got up and tried again, but the officer swung the cord again near his face.

In another incident, the same officer grabbed the back of the shirt of a migrant trying to run up the bank with bags of food.

Both people appeared to eventually slip past while the officers tried to hold back migrants who were scattering in all directions. A group of some two dozen people were later seen seated on the U.S. side of the river's edge behind yellow tape near several patrol cars.

Of the 16,740 migrants, 6,297, or 38%, were from Asia, Africa, Europe or other parts of the world outside the Americas. Migrants smugglers in Mexico have recently been trying some innovative methods, including ferrying migrants for hundreds of miles on the backs of motorcycles or smuggling them in vehicles with fake logos.

Authorities stopped migrants more than 1.7 million times during the fiscal year that ended Sept. 30, nearly quadruple from 458,088 in the previous fiscal year, when COVID-19 first struck.

Meanwhile, the Associated Press reported that more than 2,000 migrants began walking out of a city in southern Mexico on Saturday where they have essentially been trapped. The migrants walked along a highway leading west and north toward the U.S. border and pushed past a line of state police who were trying to stop them. They made it only a few miles to the nearby village of Alvaro Obregon before stopping to rest for the night at a baseball field. Tens of thousands of migrants from Honduras, El Salvador and Haiti have been waiting in the southern city of Tapachula for refugee or asylum papers that might allow them to travel, but have grown tired of delays in the process.

CIUDAD ACUÑA, Mexico, Sept 19 (Reuters) - A U.S. law enforcement officer on horseback wielded what appeared to be a lariat, whipping it close to the face of a man wading in the Rio Grande carrying a plastic bag of food.

It was just one desperate moment in a few hours of such scenes along the Rio Grande on Sunday.

Hundreds of Haitian migrants who have been camping under a bridge in the Texas town of Del Rio were trying to bring food and other supplies from Ciudad Acuña in the Mexican state of Coahuila, while U.S. officials have stepped up security at the border and started flying migrants out of the area, some to Haiti.

Migrants said their squalid encampment under a bridge on the U.S. side of the river was short of supplies. U.S. officials over the last few days had let migrants cross back and forth at a shallow point of the river. On Sunday, however, they told migrants they would not be able to return to the U.S. side if they ventured into Mexico.

"We're trapped," said Joncito Jean, 37, who had spent three days sleeping on a sheet on the ground with his wife and children, ages 3 and 4. He said he regretted the decision to come.

"There are no humane conditions... We have to break out to buy water."

More than 12,000 migrants, identified by officials on both sides as mostly Haitian, have been gathering under the bridge in recent days, awaiting immigration processing. Instead, U.S. officials began removing several thousand people from the camp over the weekend, including some who were later seen arriving in Haiti.

Still, several people who spoke to Reuters, most of whom traveled with their children, said they would take their chances to try to stay in the United States.

Mackenley Pearre, 25, left impoverished Haiti in July with his cousin, wife and 2-year-old daughter due to the worsening violence and inability to find work as an electrician. In July, Haiti's president was assassinated, and in August a major earthquake and powerful storm hit the country.

"You have to do something to not die of hunger," he said, eating a tamale given to him by a local resident on the Mexican side, one of several people who said they felt moved to help.

At a news conference in Del Rio Sunday, U.S. Border Patrol Chief Raul Ortiz said resources were available.

"We are providing food, water, portable toilets, towels, emergency medical technicians are available for first aid," Ortiz said.

"Over the next 6 to 7 days our goal is to process the 12,662 migrants that we have underneath that bridge as quickly as we possibly can," Ortiz said. "What we want to make sure is that we deter the migrants from coming into the region so we can manage the folks that are under the bridge at this point."

At the border, migrants waded deeper to try to evade law enforcement. Mostly men, many barefoot and in boxers, attempted trickier crossings through waist-deep water. Some migrants crossed at another point where water reached their necks.

Reuters journalists saw mounted officers wearing cowboy hats and vests emblazoned with "POLICE U.S. BORDER PATROL" blocking the path of migrants scrambling up the U.S. embankment carrying plastic bags and cardboard boxes.

After one of the officers in the vests unfurled a cord resembling a lariat like a whip and steered his horse to block the migrants, one tumbled back into the water. He got up and tried again, but the officer swung the cord again near his face.

In another incident, the same officer grabbed the back of the shirt of a migrant trying to run up the bank with bags of food.

Both people appeared to eventually slip past while the officers tried to hold back migrants who were scattering in all directions. A group of some two dozen people were later seen seated on the U.S. side of the river's edge behind yellow tape near several patrol cars.

‘I promise you, those people will pay’: Biden slams border agents who whipped migrants

‘It’s horrible what you saw. To see people like they did, with horses, running them over, people being strapped, it’s outrageous,’ Biden says

President Joe Biden has slammed the border agents who whipped migrants from horseback in Del Rio, Texas as people tried to enter the US after fleeing natural disasters and political turmoil in Haiti.

“It’s horrible what you saw. To see people like they did, with horses, running them over, people being strapped, it’s outrageous,” Mr Biden said on Friday.

“I promise you – those people will pay,” he added. “There is an investigation underway right now and there will be consequences.”

“It’s an embarrassment,” the president said. “It’s beyond an embarrassment. It’s dangerous, it’s wrong. It sends the wrong message around the world. It sends the wrong message at home. It’s simply not who we are.”

An investigation has begun following video footage emerging earlier this week showing border agents on horseback aggressively trying to push back migrants, and at times swing long reins towards people on the ground.

Administration officials and congressional Democrats have shared their anger over the behaviour of the border agents. The Department of Homeland Security has suspended the use of horse patrols for the time being.

The CBP’s Office of Professional Responsibility is leading the investigation and it’s expected to be finished next week.

“Of course I take responsibly,” Mr Biden told reporters. “I’m President.”

Democratic California Representative Maxine Waters said during a press briefing on Wednesday: “What we witnessed takes us back hundreds of years. What we witnessed was worse than what we witnessed in slavery.”

“Cowboys with their reins, again, whipping Black people, Haitians, into the water where they’re scrambling and falling down when all they’re trying to do is escape from violence in their country,” she added.

“I’m pissed. I’m unhappy and I’m not just unhappy with the cowboys, who were running down Haitians and using their reins to whip them,” Ms Waters said. “I’m unhappy with the administration.”

The White House has faced criticism for continuing its deportations of Haitian migrants, but has defended the policy, arguing that they are trying to install an “orderly and humane process”.

“Our policy process has continued to be the same with Haiti as it is for anybody coming through an irregular migration across our border,” White House Press Secretary Jen Psaki said on Thursday.

A large number of the migrants trying to enter the US are being removed under Title 42 – a policy that began under the Trump administration and that allows the US to expel migrants without allowing them to apply for asylum if they pose a public health risk. During the pandemic, Title 42 have blocked many from entering the US at the southern border.

Some Democrats have urged the Biden administration to put a stop to the removals of Haitians as their country faces multiple crises – an earthquake recently killed more than 2,000 people and caused widespread devastation, the country has not managed to take control over the spread of Covid-19 and has a very low vaccination rate, and political chaos has gripped the country since President Jovenel Moïse was assassinated on 7 July.

The US Special Envoy to Haiti Daniel Foote resigned on Wednesday, laying out his outrage at the handling of the crisis in a scathing resignation letter.

“I will not be associated with the United States’ inhumane, counterproductive decision to deport thousands of Haitian refugees and illegal immigrants to Haiti, a country where American officials are confined to secure compounds because of the danger posed by armed gangs in control of daily life,” he wrote.

State Department spokesperson Ned Price fired back, saying in a statement: “It is unfortunate that, instead of participating in a solutions-oriented policy process, Special Envoy Foote has both resigned and mischaracterized the circumstances of his resignation. He failed to take advantage of ample opportunity to raise concerns about migration during his tenure and chose to resign instead.”

Immigration authorities will not fly any of the thousands of Haitian migrants caught crossing the U.S.-Mexico border in recent weeks to Guantanamo Bay, DHS said Wednesday, after a recent request for bids to run a holding center at the U.S. naval base in Cuba generated confusion and outrage. The United States uses Guantanamo Bay to hold and process migrants apprehended at sea, and will not hold people caught at the southern border there, DHS Assistant Secretary of Public Affairs Marsha Espinosa tweeted Wednesday evening. Espinosa said a bid solicitation from ICE last week that asked private companies to apply to operate the Guantanamo Bay facility was a "typical, routine first step in a contract renewal."

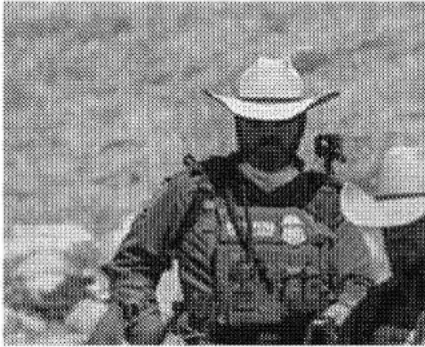

One photo depicts a BPA grabbing the shirt of a migrant running up an embankment and another captures what was described in the article as "one of the officers...unfurled a cord resembling a lariat like a whip and steered his horse to block the migrants, one tumbled back into the water. He got up and tried again, but the officer swung the cord again near his face."

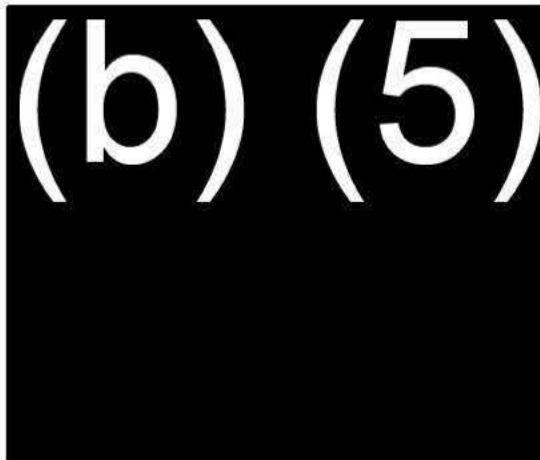

CIUDAD ACUÑA, Mexico, Sept 19 (Reuters) - A U.S. law enforcement officer on horseback wielded what appeared to be a lariat, whipping it close to the face of a man wading in the Rio Grande carrying a plastic bag of food.

It was just one desperate moment in a few hours of such scenes along the Rio Grande on Sunday.

Hundreds of Haitian migrants who have been camping under a bridge in the Texas town of Del Rio were trying to bring food and other supplies from Ciudad Acuña in the Mexican state of Coahuila, while U.S. officials have stepped up security at the border and started flying migrants out of the area, some to Haiti.

Migrants said their squalid encampment under a bridge on the U.S. side of the river was short of supplies. U.S. officials over the last few days had let migrants cross back and forth at a shallow point of the river. On Sunday, however, they told migrants they would not be able to return to the U.S. side if they ventured into Mexico.

"We're trapped," said Joncito Jean, 37, who had spent three days sleeping on a sheet on the ground with his wife and children, ages 3 and 4. He said he regretted the decision to come.

"There are no humane conditions... We have to break out to buy water."

More than 12,000 migrants, identified by officials on both sides as mostly Haitian, have been gathering under the bridge in recent days, awaiting immigration processing. Instead, U.S. officials began removing several thousand people from the camp over the weekend, including some who were later seen arriving in Haiti.

Still, several people who spoke to Reuters, most of whom traveled with their children, said they would take their chances to try to stay in the United States.

Mackenley Pearre, 25, left impoverished Haiti in July with his cousin, wife and 2-year-old daughter due to the worsening violence and inability to find work as an electrician. In July, Haiti's president was assassinated, and in August a major earthquake and powerful storm hit the country.

"You have to do something to not die of hunger," he said, eating a tamale given to him by a local resident on the Mexican side, one of several people who said they felt moved to help.

At a news conference in Del Rio Sunday, U.S. Border Patrol Chief Raul Ortiz said resources were available.

"We are providing food, water, portable toilets, towels, emergency medical technicians are available for first aid," Ortiz said.

"Over the next 6 to 7 days our goal is to process the 12,662 migrants that we have underneath that bridge as quickly as we possibly can," Ortiz said. "What we want to make sure is that we deter the migrants from coming into the region so we can manage the folks that are under the bridge at this point."

At the border, migrants waded deeper to try to evade law enforcement. Mostly men, many barefoot and in boxers, attempted trickier crossings through waist-deep water. Some migrants crossed at another point where water reached their necks.

Reuters journalists saw mounted officers wearing cowboy hats and vests emblazoned with "POLICE U.S. BORDER PATROL" blocking the path of migrants scrambling up the U.S. embankment carrying plastic bags and cardboard boxes.

After one of the officers in the vests unfurled a cord resembling a lariat like a whip and steered his horse to block the migrants, one tumbled back into the water. He got up and tried again, but the officer swung the cord again near his face.

In another incident, the same officer grabbed the back of the shirt of a migrant trying to run up the bank with bags of food.

Both people appeared to eventually slip past while the officers tried to hold back migrants who were scattering in all directions. A group of some two dozen people were later seen seated on the U.S. side of the river's edge behind yellow tape near several patrol cars.
