Pilot Rollout for November 1st Partner Government Agencies

In preparation for the November 1, 2015 ACE mandatory filing date, 14 Partner Government Agencies (PGAs) will participate in controlled, technical tests of their PGA Message Set and/or DIS functionality at 12 selected ports, starting in August 2015.

Requirements:

Technical

- Programming must meet requirements specified in the supplemental PGA CATAIR guidelines.
- Test participants must use a software program that has completed ACE certification testing for the PGA Message Set.

Geographic

- Test participants must be ready to file transactions at the port locations indicated for each phase of the pilot.
